Information on the tourist access to the *Camminamento di Ronda* of the city walls of Marostica

The Associazione Pro Marostica, C.F. 91006230246 and P.I.00898120241, located in Marostica (VI), Piazza Castello n. 01 informs the tourists (or the persons over whom they exercise guardianship or parental responsibility) who intend to use the pedestrian tourist route of the city walls of Marostica, cd. "*Camminamento di Ronda*" or "*Camminamento*", realized by the City of Marostica and managed by Associazione Pro Marostica, that in order to access the site, they must follow the INSTRUCTIONS provided by the security staff with specific reference to:

a. the risks arising from the fruition of the Walk;

b. the <u>procedures for the completion of the visit;</u>

c. the slopes and salient characteristics of the Walk;

d. the operations to be carried out in case of <u>sudden illness/accident;</u>

e. how to **use Category III PPE fall arrest harness** with sternal and dorsal fall arrest attachment (EN 361); lanyard with energy absorber, length 1 (one) m (EN 354-355);

f. <u>theoretical/practical information on the use of PPE</u>, including demonstration of the operations necessary to: wear a harness that fits snugly around the body using appropriate adjustments; connect the end of the lanyard cord absorber to the sternal attachment of the harness with the connector; connect the other connector to the mobile anchorage device;

g. the obligation <u>**not to disengage</u>** from the fall arrest system <u>for any reason</u> without the assistance of the personnel;</u>

h. the obligation to <u>wear comfortable clothing</u>, the adequacy of which is evaluated by the security staff who, in case of inadequacy, may prevent or restrict access to the walkway;
i. the <u>obligation to return the equipment</u> at the end of the route, reporting any imperfections, damages or anomalies found during the usage. The Associazione Pro Marostica also **informs** users (or persons over whom they exercise guardianship or parental responsibility) who intend to access the *Camminamento di Ronda* that they MUST:

a. have **<u>a suitable physique</u>** for the use of the safety devices provided for the Walk;

b. weigh less than 100 kg;

c. be taller than 120 cm;

d. <u>refrain</u> from accessing the Walk <u>if they are not in perfect health conditions or are in</u> <u>unsuitable medical conditions</u> (e.g.: heart disease, high/low blood pressure, epilepsy, visual impairment, fear of heights, dizziness, balance difficulties, limb mobility problems, alcohol abuse and/or drug addiction...). Having taken note of the above, **<u>BY PURCHASING THE TICKET</u>** the user <u>accepts</u> the above conditions and <u>declares</u> that he/she has been duly informed about the methods of use of the protection devices, the physical conditions necessary to access and walk the *Camminamento di Ronda*, and <u>undertakes</u> to comply with the information/instructions and requests of the security personnel, to respect the regulation of the technical manual, to protect his/her own and others' safety and security in every phase of the visit, <u>exonerating</u> the Municipality of Marostica, the Associazione Pro Marostica and the staff in charge of security from any civil and criminal responsibility for any accident, injury or illness, as well as damages to property or things, resulting from any operation and activity regarding the visit (including operations in the preparatory, final and exit phases), and damages caused by other participants during the visit.
